

MEMORANDUM OF UNDERSTANDING BETWEEN AMANGALA UNIVERSITY OF TECHNOLO

RAJAMANGALA UNIVERSITY OF TECHNOLOGY RATTANAKOSIN, THAILAND



AND

RESTAURATION FELDBERGER HOF GmbH, GERMANY

In order to promote the cooperation which can further be developed into a partnership between Rajamangala University of Technology Rattanakosin represented by its President, Associate Professor Dr. Udomvit Chaisakulkiet, located at 96 Phuttamonthon Sai 5 Road, Salaya, Phutthamonthon, Nakhon Pathom, 73170, Thailand (herein referred to as "RMUTR"), on the one hand; and Restauration Feldberger Hof Banhardt GmbH represented by its Chief Executive Officer, Mr. Sebastian Banhardt, located at Dr. -Pilet-Spur 1, 79868 Feldberg, Germany (herein referred to as "Feldberger Hof"), on the other hand.

The two institutions have made the following understanding.

1. Purpose of MOU

- 1.1 Enable students' opportunities to apply academic theories to practical situations,
- 1.2 Promote international cooperative education and CWIE, and
- 1.3 Other forms of cooperative education and CWIE, student affairs, and academic collaboration.

2. Goals of Operation

- 2.1 Students gain the hands-on experience working in the hospitality industry,
- 2.2 Students gain professional experience in an international environment, explore the new cultures, languages and ways of working, and
- 2.3 The academic collaboration between RMUTR and Feldberger Hof.

3. Scope of Cooperation of RMUTR

- 3.1 Conduct an interview and the selection process of students who would like to participate in an international internship program at Feldberger Hof,
- 3.2 Assist and provide necessary documents for its students to apply for the Schengen visa before their departure,
- 3.3 Advise its students about cultural expectations of Germany, and
- 3.4 Provide an orientation program for incoming internship students.

4. Scope of Cooperation of Feldberger Hof

- 4.1 Provide necessary documents for incoming internship students for the Schengen visa application,
- 4.2 Provide the round-trip ticket from Bangkok to Frankfurt for incoming internship students who meet the eligibility,
- 4.3 Provide food and assist the incoming internship students in securing housing,
- 4.4 Assign a supervisor to the incoming internship students,
- 4.5 Inform the incoming student of health insurance requirements, and
- 4.6 Provide RMUTR with feedback of the internship student's performance.

5. Duration of the MOU

This MOU will become effective for a period of 3 (three) years starting from the date of signature by the representatives of the two institutions. The MOU will be renewed for an additional period of 3 (three) years, unless either institution provides a written notice of termination at least 6 (six) months prior to the end of the first three-year period.

In any case of termination, both institutions must undertake to continue their commitment and the obligations that would result from the separation agreement as stipulated in this MOU till it is completed to avoid any discrepancies with the other institution.

6. Amendments or Modification of the MOU

This MOU may be amended or modified from time to time following the consultation and mutual decision in written by both institutions.

Each institution acknowledges that this MOU is non-legally binding. Each of the cooperated activities may, however, be developed into an agreement.

This MOU is signed in duplicate in English. Both documents will be deemed as originals. Both institutions have read and understood the purpose thoroughly, and have set their hands in the presence of witnesses in evidence hereof.
