## MEMORANDUM OF UNDERSTANDING

On Academic Collaboration

between

RAJAMANGALA UNIVERSITY OF TECHNOLOGY RATTANAKOSIN

and

RBD CO., LTD. (Restaurateurs Sans Frontieres)

This Memorandum of Understanding is made on 13 December 2024 between Rajamangala University of Technology Rattanakosin represented by its President, Associate Professor Dr. Udomvit Chaisakulkiet, located at 96, Phuttamonthon Sai 5 Road, Salaya, Phutthamonthon, Nakhon Pathom, 73170, (hereinafter referred to as "RMUTR") on the one hand; and RBD Co., Ltd. represented by its CEO, Mr. Robert Bougrain Dubourg, located at 6, Kasemsan 2 Alley, Rama 1 Road, Wang Mai, Pathum Wan, Bangkok, 10330, (hereinafter referred to as "RBD"), on the other hand.

The two parties have made the following understanding.

### 1. Purposes of MOU

This Memorandum of Understanding has the purposes as follows;

- 1.1 Promotion of the cooperation on the development, the exchange of knowledge, the increase in capabilities through training activities and the application of knowledge gained to effective actual professional activities with optimal benefits according to the objectives of both RMUTR and RBD
- 1.2 Enhancement of the cooperation in preservative, conservative, and protective restoration all types of artworks or all of their forms of integration
- 1.3 Enhancement of the collaboration and development of practicum training and instruction of RMUTR (in particular in programs under the responsibilities of its Poh-Chang Academy of Arts) applicable to relevant subject courses or programs and
- 1.4 Nurturement of hands-on graduates with necessary competencies for professional preservative, conservative, and protective restoration all types of artworks leading to the development of entrepreneurial societies.

## **2. Goals of Operation**

The goals of this Memorandum of Understanding are as follows;

- 2.1 Grooming of RMUTR's students with competencies required in the preservative, conservative, and protective restoration all types of artworks
- 2.2 Determination of quality and permanent organization in the field of professional art restoration for RMUTR's student internship and/or Cooperative and Work-integrated Education programs
- 2.3 Nurturement of hands-on graduates with competencies required for the entrepreneurial society.

## **3. Scope of RMUTR**

- 3.1 Provision of support, academic knowledge, or other relevant activities,
- 3.2 Provision of academic support and development, including degree awarding programs, training courses, and research projects,
- 3.3 Conduct the Analysis to determine the direction for the curriculum development in the area of art conservation and restoration.

## **4. Scope of Cooperation of RBD**

- 4.1 Provision of support, academic knowledge, or other activities related to teaching and instruction in areas related to the restoration and conservation of artworks and all forms of their integration,
- 4.2 Provision of support for knowledge development, for the further acquisition of capabilities through training, and the application the knowledge gained to actual professional practices with the maximum effectiveness and benefit in accordance with the objectives of the MOU,
- 4.3 Provision of support for the non- degree awarding courses, degree awarding courses, teaching and instruction, and the development of hands-on graduates with knowledge and ability to the entrepreneurial society.

## **5. Term of the MOU**

This MOU will become effective for a period of 3 years since the date of signature by the authorized persons of both parties.

This MOU may be terminated by either party with a minimum of 30 days written notice.

In case either party desires to extend the MOU for such a further period, it must inform the other party in written before the termination date of this MOU. Both parties must be agreed upon and formalized by the signatures of a written addendum signed by the authorized persons of both parties.

In any case of termination, both parties must undertake to continue their commitment and the obligations that would result from the separation agreement as stipulated in this MOU till it is completed to avoid any discrepancies with the other parties.

#### 6. Amendments or Modification of the MOU

This MOU may be amended or modified from time to time following the consultation and mutual decision in written by both parties.

#### 7. Other Conditions

This MOU is signed in duplicate in English. Both documents will be deemed as originals. Both parties have read and understood the purpose thoroughly, and have set their hands in the presence of witnesses in evidence hereof. Each party will keep one original copy.


